COOKIE POLICY

1. Introduction

Our website, <https://www.eagleburgmann.com.tr/> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). Cookies are also placed by third parties we have engaged. In the document below we detailed inform you regarding the use of cookies on our website within the scope of the Turkish Personal Data Protection Law (KVKK) and General Data Protection Regulation ("GDPR").

2. What are cookies?

A cookie is a small simple file that is sent along with pages of this website and stored by your browser on the hard drive of your computer or another device. The information stored therein may be returned to our servers or to the servers of the relevant third parties during a subsequent visit.

3. Explicit Consent

When you visit our website for the first time, we will show you a pop-up with an explanation about cookies. As soon as you click on "Cookie Policy", you examine the categories of cookies and plug-ins you selected in the pop-up, as described in this Cookie Policy. **You can disable the use of cookies through your browser, but necessary (functional) cookies required for our website to function will continue to be effective. If this is not your preference, you must terminate your visit.**

Your data collected with cookies are transferred abroad because the servers of our web site and 3rd party cookie servers are located abroad. If this is not your preference, you must terminate your visit.

4. Cookies

4.1. Necessary (functional) cookies

Some cookies ensure that certain parts of the website work properly and that your user preferences remain known. By placing functional cookies, we make it easier for you to visit our website. This way, you do not need to repeatedly enter the same information when visiting our website.

We may place these cookies without the need for explicit consent of these cookies, in accordance with the Turkish Personal Data Protection Law **Art. 5/2-e and f, "Data processing is necessary for the establishment", "exercise or protection of any right", "Processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject"**.

4.2. Analytical cookies

We use analytical cookies to optimize the website experience for our users. With these analytical cookies we get insights in the usage of our website. We need explicit consent from you to place analytical cookies.

6.Your rights regard to personal data

If your personal data is processed by the Data Controller (Eagle Burgmann End.Sizd.San.ve Tic.Ltd.Şti.) and the Data Controller processes your data as a data controller, you have the following rights regarding your personal data:

- to learn whether his personal data are processed or not,
- to request information if his personal data are processed,
- to learn the purpose of his data processing and whether this data is used for intended purposes,
- to know the third parties to whom his personal data is transferred at home or abroad,
- to request the rectification of the incomplete or inaccurate data, if any,
- to request the erasure or destruction of his personal data under the conditions laid down in Article 7,
- to request notification of the operations carried out in compliance with subparagraphs (d) and (e) to third parties to whom his personal data has been transferred,
- to object to the processing, exclusively by automatic means, of his personal data, which leads to an unfavourable consequence for the data subject,
- to request compensation for the damage arising from the unlawful processing of his personal data.

Request to the Data Controller

You can send your requests within the scope of Article 11 of the Law regulating the rights of the data subject, to the physical address of the Data Controller in writing or to your e-mail address on which your membership has been confirmed, in accordance with the "Communique On The Principles And Procedures For The Request To Data Controller Regulation".

7. Disabling cookies

You can use your internet browser to automatically or manually delete cookies. You can also specify that certain cookies may not be placed. Another option is to change the settings of your internet browser so that you receive a message each time a cookie is placed. For more information about these options, please refer to the instructions in the Help section of your browser.
