GENERAL EXPLANATIONS:

Personal data holders, who are defined as the relevant person in the Law on Protection of Personal Data No. 6698, have been granted certain rights regarding the processing of their personal data in Article 11 of the Law.

In accordance with the first paragraph of Article 13 of the Law; Applications to our company, which is the data controller, regarding these rights should be submitted to us in writing or by other methods determined by the Personal Data Protection Board.

Within this framework, the applications to be made to our Company in writing are printed out of this form;

- With the applicant's personal application
- Through a notary public,
- By signing with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 by the Applicant and sending it to the registered e-mail address of the Company
- If you previously provided an e-mail address to your Data Officer, where your identity was confirmed, by applying from this e-mail address should be forwarded to us.
